1. Describe and implement the updated recommendations from the Centers for Disease Control

and Prevention (CDC) regarding the new Blood Lead Reference Value (BLRV).

2. Implement California's Childhood Lead Screening mandates and include anticipatory guidance in routine childhood visits.

3. Appropriately screen, follow-up, and manage children with elevated blood lead levels.

4. Recognize potential risk factors and lead exposure sources and provide targeted individualized screening when appropriate.

5. Reduce bias when assessing lead exposure risk, by increasing knowledge of cultural and other risk factors and behaviors that can affect all demographic and socioeconomic groups, in addition to risk factors associated with lower socioeconomic status (SES).
